## MEMORANDUM OF UNDERSTANDING (MoU)



### 2. PURPOSE

2.1 WHEREAS 'EWING CHRISTIAN COLLEGE, PRAYAGRAJ' is interested in entering into Memorandum of Understanding (MoU) to further its various outreach programs including ones in cleanliness, health, women's and girls' empowerment, education, environment and well-being of vulnerable groups. Accordingly, the areas of co-operation will include, subject to mutual consent, any areas of extension and outreach, as felt desirable and feasible on either side and that both sides will contribute to the fostering and development of the cooperative relationship between the two 'Parties'.

And

WHEREAS 'A N SEWA NYAS is interested in collaborating with EWING CHRISTIAN COLLEGE, PRAYAGRAJ, to mutually explore, extend and strengthen a reciprocal relationship for the promotion of extension programs and capacity building by sharing the facilities and expertise available with both 'Parties'.

The specific areas of Collaboration between the two 'Parties' shall include the following:

- a) Joint Extension and Outreach
- b) Participation in Seminars/ Lectures etc. organized by either Party or both Parties
- c) Organizing joint Seminars/ Lectures etc.
- d) Voluntary Service with prior consent of both 'Parties'
- e) Exchange of information and research with prior consent of both 'Parties'

2.2 A Memorandum of Understanding (MoU) shall be developed for specific agreements based on the mutually agreed upon objectives and outcomes, at any time, but require the signatures of both Principal and Registrars or expressly designated delegates.

2.3 The purpose of this Memorandum of Understanding is to outline an extension and outreach framework between the two parties, designed to promote service orientation at both institutions. The parties do not intend to be bound to each other, and this Memorandum of Understanding does not impose legal obligations on either party.
