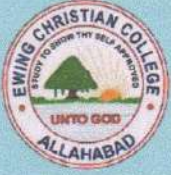
For exchange of Sports Knowledge, Information, Facilities and Training

THIS MEMORANDUM OF UNDERSTANDING (MoU) is executed at Prayagraj on this 26th (Tuesday) day of July, 2022 by and between Department of Physical Education and Sports, Ewing Christian College, Prayagraj and H.N.B. Govt. P.G. College, Naini, Prayagraj.

3. Faculty and student exchange programme for mutual benefit and sharing of the knowledge.
4. Both the institution will provide infrastructural facilities for training of athletes and for organizing competitions.
5. This agreement will come into effect from the date of signing of this agreement and shall be valid for five years from that date unless sooner terminated, revoked, or modified by mutual written agreement between the parties and may be extended by mutual written agreement.

This MOU shall be identified as the parent document of any program agreement executed between the parties. For agreed upon activities, both institutions will make available their facilities and staffs. This MOU will take effect on and will be valid for five (5) years from the date noted in the second line of this document unless terminated by one of the parties. This MOU may be renewed for another period of five (5) years upon mutual written consent of the parties before the expiration date. Each institution will have original copies of this agreement.


